Kind attention is invited to the above cited reference. As per the ref 1 & 2 the National Urban Livelihoods Mission (NULM) has replaced the Swarna Jayanti Shahari Rozgar Yojana (SJSRY) Scheme. In the first phase following 14 ULBs have been selected from our state to implement NULM.

Vide reference cited 3 above, Government has sanctioned the recruitment for the personnel to State Mission Management Unit and City Mission Management Units (CMMU) in the above cities, Kudumbashree has taken steps to recruit the functional specialists accordingly. As per the reference (4) Operational Guidelines for Capacity Building and Training (CB&T) under the NULM it is directed to appoint City Project Officer (CPO) for heading the CMMU, the mission Assistant Project Officers (APOs) document of the NULM indicated that (clause no. 13.18) "a dedicated unit City Mission Management Unit (CMMU) will be managed by a City Project Officer (CPO). The CPO will be of the rank of a Deputy Municipal Commissioner/Executive Officer and will be assisted by one or more Assistant Project Officers (APO) and a team of functional specialists. In metropolitan cities, the CPO will be assisted by at least two Assistant Project Officers (APO)" In the above circumstances

(A) Government order may be issued for authorizing the Secretaries of the above ULBs as the City Project Officers (CPOs) of the concerned NULM cities and the member secretaries of the

respective Kudumbashree CDS as the Assistant Project Officers (APOs). The functional specialists should be assigned under APOs and APOs will reported to CPO and CMMUs will be monitored by Mission Director of NULM (Executive Director, Kudumbashree) through CPOs.

The Mission document of the NULM (Clause no. 13:16) directed to constitute Executive Committee at City Level for NULM cities. LSGI level intervention and monitoring is very important for the smooth implementation of NULM. Hence Kudumbashree proposes the following members as the Executive Committee (EC) at City Level
