ORDER

As per the Government order read as 1st paper above Government had constituted two committees namely State Level Sanctioning and Monitoring Committee (SLSMC) and State Level Appraisal Committee (SLAC) as required in the Mission Guidelines of the Pradhan Mantri Awas Yojana(PMAY). The State Level Sanctioning and Monitoring Committee (SLSMC) was constituted under the chairmanship of Principal Secretary, Local Self Government Department.

The Member Secretary, Urban Housing Mission(UHM) & Executive Director, Kudumbashree in his letter read as 2nd paper above has requested Government to reconstitute the State Level Sanctioning and Monitoring Committee (SLSMC) as the Central Sanctioning & Monitoring Committee (CS&MC) headed by the Secretary, Ministry of Housing & Urban Poverty Alleviation (MOHUPA), while considering approval of the projects submitted by the State, observed that the SLSMC should be headed by the Chief Secretary as provided in the mission guidelines to get the ownership of the State. The CS&MC approved the project of the State on the condition that the State shall issue orders reconstituting the SLSMC with the Chief Secretary as the chairman.

Government have examined the matter in detail and are pleased to reconstitute the **State Level Sanctioning and Monitoring Committee** (SLSMC) under the Pradhan Mantri Awas Yojana (PMAY) with the Chief Secretary to Government of Kerala as the Chairman.
