Expression of Interest is invited from reputed organizations/ agencies for installation & maintenance of Reverse Osmosis plants for Kudumbashree units under Kudumbashree Mission. Competent organizations/ agencies that have sufficient experience in the installation & maintenance of RO plants and empanelled agencies/ service providers of other Government departments/ agencies in the installation & maintenance of RO plants are eligible for applying.

The agencies can apply for plants of varying capacity under the following categories

- Category 1: Plants of production capacity of 500 litre/ hour
- Category 2: Plants of production capacity of 1000 litre/ hour
- Category 3: Plants of production capacity of 2000 litre/ hour

EoI in the prescribed format should reach the office of the State Mission, Kudumbashree, before 4 pm of 10-01-2019. For more details, you can visit the website of Kudumbashree, www.kudumbashree.org

1. Purpose of the EoI

- 1.1 State Poverty Eradication Mission (Kudumbashree) – is the Mission formulated by Govt. of Kerala to eradicate absolute poverty. Kudumbashree works through community based organizations of women that would work in association with Local Self Governments with focus on poverty reduction and women empowerment. The Kudumbashree has reach across the state of Kerala and has coverage of 45 lakh families.
- 1.2 Kudumbashree implements Economic, Social & Women empowerment programmes through the community network. Capacity building of community based organizations of Kudumbashree for implementation of programmes and handholding them for implementation is one of the major objectives of Kudumbashree.
- 1.3 Providing livelihood support is a main activity of Kudumbashree Mission as part of economic empowerment of women. Micro Enterprises, collective farming and placement linked skill trainings are the major programmes focused by Kudumbashree under livelihood. Promotion of micro enterprises in non-farm sector as self employment among women and youth in rural & urban areas is done by the Mission. Entrepreneurship Development programme, skill trainings and handholding support is provided as part of promoting micro enterprises.
- 1.4 Technical and technological promotion is done as part of establishing enterprises as per the needs of the market. The Mission provides support in identifying the best agencies that will provide support in setting enterprises and providing required machinery.
- 1.5 The present EoI is invited to identify competent experienced agencies for supply, installation & maintenance of Reverse Osmosis plants for Kudumbashree groups across the state under Local Self Governments & Kudumbashree Mission, based on the demand from the Community Development Society/ participants.
- 1.6 The objective is to provide technological support & post installation support service to Kudumbashree entrepreneurs who intends to set RO plants as part of starting Self Employment Programme in Urban & rural areas.
- 1.7 Present EoI is published for selection of agencies for installation, maintenance and post installation support for the establishment and running of RO plants established by Kudumbashree groups across the state. *This empanelment does not guarantee any income or any work order to those who are enlisted.*

2. Submission of Applications

- 2.1. The agencies from each category should apply in the prescribed format for that category in the name of the Executive Director, Kudumbashree within the stipulated date and relevant documents.
- 2.2. The agencies may apply as Installation & Service Providers at the state level to provide Installation & post installation support on the establishment of RO plants.
- 2.3. Applications received after the submission deadline will be treated as non responsive and will be excluded from further evaluation process.
- 2.4. There is no application fee for applying as Installation & Service Providers.
- 2.5. Incomplete applications, applications submitted in wrong formats, applications without required credentials and the application with any other defects will be summarily rejected.
- 2.6. The agencies should mention the districts they can provide installation and support services specifically.
- 2.7. The agencies will be considered for districts for which they have applied and will not consider for any other districts thereafter. However, Kudumbashree Executive Director has the right to take decision regarding giving work order to any empanelled agency depending on the demand.
- 2.8. The applicants should submit all relevant documents as per the EoI within the prescribed time and will not give further time for submission of credentials.
- 2.9. The applicants are advised to study the EoI document carefully before submitting the applications.

3. Communication regarding this EoI notification

- 3.1. All the details pertaining to the EoI, list of shortlisted agencies after the EoI will be published on the website www.kudumbashree.org immediately after the completion of each process.
- 3.2. Information relating to the evaluation of proposals and award recommendations shall not be disclosed to the agencies who have submitted the proposals or to any other party not officially concerned with the process, until the publication of the list. The agencies should not contact any of the officials of Kudumbashree on any matter related to its proposal or process. 3.3. The agencies will be intimated officially in the address stated or e-mail submitted when shortlisted for making presentations and negotiation.

4. Eligibility Criteria

1. Agencies that have minimum 3 years experience in the installation & maintenance of RO plants
2. Installed at least 10 plants in the last 2 years.
3. Should have a turnover of at least Rs. 1 crore per year on an average for the last 3 years.
4. The agency should not be black listed by any government or its agencies
5. Agencies that have service centre in Kerala will be given preference.

4.1. The objective of Kudumbashree in inviting the institutions/ agencies is to pool different agencies that have experience in the concerned field thereby providing quality plants and service to Kudumbashree women/ groups.

- 4.1.1. The agencies should be a registered organization in India with minimum maturity of three years as on 31.3.2018
- 4.1.2. The agencies should have at least three years experience in the field of installation, maintenance and post installation services on RO plant in South India as on 31.3.2018
- 4.1.3. The agencies should have sufficient infrastructure, technical experts and facilities for the installation & support services in South India; preferably in Kerala.
- 4.1.4. The agencies should be able to provide warranty, post installation support services whenever it is required.

5. Criteria for Technical /financial Appraisal

- 5.1. Relevant experience in installation, maintenance and post installation support services
- 5.2. Annual maintenance support provided
- 5.3. Warranty for the product offered
- 5.4. Cost effectiveness of the system (capital cost and operational cost)
- 5.5. Availability of service centre in Kerala
- 5.6. Infrastructure and capacity of agency/ organization
- 5.7. Experience in the field in South India
- 5.8. HR potential to provide services
- 5.9. Transparency and accountability
- 6.0. Readiness to provide support services on call

6. Process of Empanelment & awarding of contract

- 6.1. After the deadline for submission of the proposal, list of application received under this EoI will be published on Kudumbashree website.
- 6.2. The applications received without proper documents stipulated will be summarily rejected.
- 6.3. The organizations who have submitted valid applications will be invited for a presentation before the State level committee constituted for the empanelment of the agencies. The details of these shortlisted agencies will be published in Kudumbashree website.
- 6.3. Credentials of the organizations for their basic eligibility will be verified before the presentation by the agencies.
- 6.4. The infrastructure, Human resources and credential of the organization will be verified. The feedback of agencies/ institutions where the installation & support provided will be analyzed.
- 6.5. The agencies will be empanelled based on presentations & feedback from the field. The presentations should cover the technical and financial aspects of the implementation & support services. The final list of empanelled agencies will be published after the process is over.
- 6.6. The technical & financial aspects made by the organizations in the presentation will be evaluated by a technical committee at state level. The Technical committee will evaluate the technical specifications, financials on installation of plant, warranty, post installation support offered, supply of consumables and maintenance support offered.
- 6.7. Request for proposal (RFP) will be issued to the empanelled agencies by the concerned districts/ Local Self Governments based on demand.
- 6.8. Based on the decision taken on the RFP, the concerned District Missions of Kudumbashree/ Local Self Governments will enter into agreement with the organizations/ agencies for the installation & support services as per the requirement from Community Development Societies (CDSs) or entrepreneurs from the Kudumbashree network.
- 6.9. *The organization/ agencies black listed by any government firm/ LSGs/ Kudumbashree previously will not be considered and the applications will be summarily rejected.*

7. Period of validity of the empanelment

The empanelment will be valid for three years from the date of empanelment. In special circumstances, the State Mission may empanel an agency even for a lesser period. As per requirement and based on the performance of the agency, the

State Mission can extend the empanelment period of one or more agencies after 3 years. Guidelines regarding this will be issued later.
