PRM Minutes- 14th & 15th July 2017

<u>Deendayal Antyodaya Yojana - National Urban Livelihoods Mission</u>

Achievements with respect to Targets under the components of NULM **for the time** period April to 15th July 2017 was reviewed by Programme Officer (Urban). Targets for the next month until 15th August 2017 were presented. Issues to be addressed and role of DMCs in monitoring the progress of implementation was emphasized.

Discussion points under NULM Components

Social Mobilization and Institution Development (SM&ID):

Key Observations on achievements until 15th July 2017

- 1. New NHG formation 100% achievements for all districts except for Thrissur
- 2. NHG bank linkage 332 achieved /951 targeted
- 3. Dormant NHG bank linkage 67 out of 279
- 4. Under the RF disbursed category the district wise achievement is not very satisfactory.

Employment through Skill Training and Placement

- 1. Seven districts viz; Pathanamthitta, Kottayam, Idukki, Alappuzha, Ernakulam, Kozhikode and Wayanad have achieved the target assigned for June with respect to enrolment of candidates in skill trainings. These districts have exceeded the target. Ernakulam district have 221% achievement and Kotayam 201%.
- 2. Thiruvananthapuram has achieved 88% of the target and Kollam has achieved 73%
- 3. It needs to be seriously viewed that the Mission Management units of Kasaragod, Kannur and Palakkad have not enrolled a single candidate either for residential training or for non residential training. There are many attractive courses available in residential mode in various centres. District Missions should take necessary steps to achieve the target for the coming months and the back log of the first quarter.
- 4. Skill training for self employment also can be imparted under this component of NULM. However the candidates should be willing to undergo the training in each job role as per the curriculum approved by Government of India.

Self Employment Programme & Bank Linkage

Targets to be achieved before next PRM (August)

- 1. The financial target for **interest subsidy** on linkage loan is **Rs. 5.08 crores**. The districts should ensure that the CMMs have send applications for sanctioning interest subsidy as per their targets.
- 2. The districts should take steps for the **identification of beneficiaries** for SEP-Individual and Groups. The districts through **SEP campaign** should conduct ward/CDS wise GOT for the identification of beneficiaries. The service of MECs may be availed. The SEP campaign should be completed before August 10th.
- 3. Conduct of **one batch of EDP training** through **RSETI**s or accredited agencies in the month of July-August for identified beneficiaries where SEP campaign is completed.
- 4. The data entry of **Linkage campaign** details should be completed before 31st July 2017 in the given format through CDS accountants or MECs.
- 5. **Starting of one wellness centre** in the district assessing the viability
- 6. Identification of **15-20 beneficiaries for housekeeping units** in one ULB of the district and should start skill training to them.
- 7. Clearance of all **pending SEP applications** in the banks. (List attached)
- 8. Data collection on Kudumbashree women who are running small food shops and are street vendors

Shelters for Urban Homeless and Support to Urban Street Vendors

- 1. There are four Urban Local Bodies (ULBs) in Alappuzha, Thrissur, Palakkad and Kasargod district to complete the street vendor survey (Chengannur, Wadakkanchery, Pattambi and Neeleswaram). DMC concerned should ensure that the survey completed in all ULBs in time.
- 2. Submit the list of urban Kudumbashree members who are engaged in street vending. Also submit the list of food street vendors under all urban local bodies.
- 3. Submit DPR for the development of street vending market at Kozhikode and Kasargod before 30th July 2017. Facilitate Identification of suitable sites for the development of street vendor market (One in each district).
- 4. Submit DPR for the construction of shelter homes in all districts (one per district). Special attention to be made for the construction of shelter homes attached to Medical College Hospital and General hospital for patient attendees. Construction of "she-lodge' and working women's hostel may also be considered.
- 5. Kozhikode, Kasargod, Palkkad, Malappuram, Pathanamthitta and Idukki district have not even submitted a single DPR for the construction/refurbishment of shelter homes. DMCs need ensure the submission of DPR.
- 6. Complete urban street dwellers survey before 15th August 2017 in all urban local bodies.
- 7. Complete construction work of all sanctioned shelter homes. (Kollam- 5, Alappuzha- 1, Kottayam-1, Ernakulam-5, Thrissur-1, Kalpetta-1 and Kannur-1).
