



NOTICE INVITING QUOTATION

Sealed quotation is invited from reputed, eligible, FSSAI notified NABL accredited labs for testing premix (micro nutrients) and fortified nutrimix for the financial year 2020-21. The Fortified nutrimix is a nutritional supplement suitable for 6 months to 3 year children, which is produced by Kudumbashree microenterprise units and is supplied through anganwadis as Take Home Ration(THR).

Required Quantity:

The selected NABL accredited lab need to test samples of premix used in fortification and also the samples of fortified nutrimix whenever needed. Initially there will be 6 samples of premix for quality testing. Please see Annexure 1 for the format of quoting the cost of testing premix/sample. Kudumbashree may approach laboratory for conducting the quality test of fortified Amrutham Nutrimix, . The samples will be send directly by Kudumbashree State Mission/ Kudumbashree District Mission through courier. Variable Quotes may be given if rates vary with increased no. of samples.

Scope of work for the selected laboratory:

1. The laboratory is expected to test the micronutrient level in premix and fortified THR. The micronutrients which is needed to be test is given as follows:- **Calcium, Iron, Zinc, Vitamin A, Thiamine, Riboflavin, Niacin, Vitamin B6, Vitamin C, Folic acid, Vitamin B12.** And the microbiological parameters:- **Coliform, Escherichia Coli, Salmonella, Moisture, Yeast and Mould Count.**
2. The laboratory is expected to **adhere to all required standard testing protocols and methods.**
3. The laboratory is expected to share the test results for each sampling activity **within 2 weeks of sample receipt** at the laboratory testing facility.
