**Order**

Kudumbashree has issued a work order vide reference 1<sup>st</sup> cited to the Skill Training Provider (STP), AMET for conducting placement linked skill training in Accounting to 35 candidates from all cities of Kerala in residential mode at their Kottarakkara centre. STP has also entered into a MoU with Kudumbashree vide reference cited 2. As per the MoU, an amount of ₹ 14568 is fixed as the training fee per successful candidate for this course with a duration of 480 hours (₹ 30.35/per hour) in addition to the assessment fee as per actual. An amount of 5000 per month per candidate is fixed as hostel fee. Vide reference 3<sup>rd</sup> an amount of ₹ 136964/-was released as first instalment of training fee and an amount of ₹ 245000 as hostel fee. Now vide reference 4. M/s AMET has requested for release of Second Instalment of training fee for 35 candidates.

As per section 6.1 (2) of the MoU, the skill training provider is eligible to get the second instalment of training fee (50% of the training cost plus the amount refunded to the trainees) on completion of training, certification, and providing placement to at least 50% of the successful candidates. The agency in the batch summary report has intimated out of the 35 candidates enrolled in the batch, 35 students have passed the course and 63% of the successful candidates are placed in job. The city Mission Manager (Skills and Livelihoods) of the concerned city has verified all the documents and has certified that the agency has fulfilled the mandatory requirements for release of second instalment. Therefore the agency is eligible to get the second instalment training fee for 34 successful students and the actual assessment fee paid to Assessment Body. In addition, STP is eligible to get the forfeited security deposit of the candidates who were absent for assessment after advance payment of assessment fee.
