**Order**

Kudumbashree has issued a work order vide reference 1<sup>st</sup> cited to the Skill Training Provider (STP), SL Electrical Works for conducting placement linked skill training in Electrician Domestic to 120 candidates from Thiruvananthapuram ULB. STP has also entered into a MoU with Kudumbashree vide reference cited 2. As per the MoU, an amount of ₹ 21864/- is fixed as the training fee per successful candidate for this course with a duration of 600 hours (₹ 36.44/per hour) in addition to the assessment fee as per actual. Vide reference 3<sup>rd</sup> an amount of Rs 147396/- was released a first instalment of training fee. Now vide reference 4<sup>th</sup> cited, M/s SL Electrical Works has requested for release of Second instalment of training fee.

As per section 6.1 (2) of the MoU, the skill training provider is eligible to get the second instalment of training fee (50% of the training cost plus the amount refunded to the trainees) on completion of training, certification, and providing placement to at least 50% of the successful candidates. The agency in the batch summary report has intimated out of the 26 candidates enrolled in the batch 19 students have passed the course and 63 % of the successful candidates are placed in job. The city Mission Manager (Skills and Livelihoods) of the concerned city has verified all the documents and has certified the same. Therefore the agency is eligible to get the second instalment training fee for 19 successful students and the actual assessment fee paid to Assessment Body. In addition, STP is eligible to get the forfeited security deposit of the candidates who were absent for assessment after advance payment of assessment fee.

Therefore the amount payable to M/s SL Electrical Works is calculated as follows:
