<b>Component wise achievements as City Mission Manager in Kozhikode Municipal Corporation</b>	
<b>1. Social Mobilization and Institution Development</b>	
<ul style="list-style-type: none"> <li>• During the period, a total of 819 families have been included in the Kudumbashree Self Helps Groups (SHG) network through the formation of 49 new NHGs. In addition, 3 SHGs for the elderly and 1 SHGs for differently abled persons have been formed</li> <li>• Apart from new formation, revived 2 Self Helps Groups during the period</li> <li>• Revolving Funds request prepared for the newly constituted SHGs whose RF claim remain pending @ Rs. 10,000/</li> <li>• Provided assistance to 170 SHGs to get linkage loan from Banks</li> <li>• Two project proposals submitted to state mission for the establishment of City Livelihoods.</li> </ul>	
<b>2. Employment through Skill Training and Placement (EST&amp;P)</b>	
<ul style="list-style-type: none"> <li>• Mobilised and enrolled 204 unemployed candidates and 94 undergone training within the city of Kozhikode for various skill training programmes under Employment through Skill Training and Placement (EST&amp;P). Among them 58 youths were passed the assessment and 37 were placed and other 3 candidates started micro enterprises units as part of self-employment programme..</li> <li>• Assisted in monitoring the performance quality of the Skill training providers (STP) of EST&amp;P Programme started skill training Centres in Kozhikode. HLPPT, CEEG, Synchroserve Global Pvt. and Accounts Training Institute (ATI) are the STPs being monitored.</li> <li>• Facilitated for the timely placements to the passed candidates with a minimum salary of Rs. 8000/ per month.</li> </ul>	
<b>3. Self Employment Programme (SEP)</b>	
<ul style="list-style-type: none"> <li>• Technical support and assistances provided to the urban poor to start micro-enterprises.</li> <li>• Provided support to 13 individuals from Urban Poor family to start micro enterprises (ME) using Bank Loans under Self Employment Programme of Day NULM. It includes 10 individual micro-enterprises and 3 group enterprises. A total of Rs.3064000/- being arranged as bank loan.</li> <li>• Identified a total of 7 individuals from the ULB for Electrician/Plumber Training. Three among them received ARISE Training in Electrician. They are now the part of Multi-task team developed by the City Livelihoods Centre.</li> </ul>	

- Shelf space for Kudumbashree products are identified at EP supermarket and Thriveni Super Markets placing their products.
- Organized 1 food fests in the ULB area and 13 Kudumbashree Catering Units participated.

#### **4. Support for Urban Street Vendors**

- Facilitated the process of issuing ID cards to selected 90 street vendors.
- Facilitated Town Vending Committee Meetings as part of the implementing Street Vendors Act-2014.
- Assisted ULB to prepare DPR for the rehabilitation of street vendors in three sites namely new bus stand, beach and SM Street.
- 69 new ID cards issued to street vendor during the period
- Drafted City Street Vending bye law plan and the same forwarded to the council approval.
- Organized 3 awareness training sessions for beach street food vendors

#### **5. Shelter for Urban Homeless**

- Assisted ULB to revise Detailed Project Report (DPR) for the construction of shelter home at Nallalam.
- Provided accommodation to a homeless street dweller in a government shelter home run by SJD.

#### **6. Other Achievements**

- We together survey to identify families without having any means of livelihoods including security pensions.
- Prepared zero waste project proposals to keep the beach litter free.
- Technical and business support provided to Theerthan R.O plant unit.
- Technical and mentoring support to the residents of Kalluthankadavu colony.
- Conducted socio economic survey of the residents of Kalluthankadavu colony as part of slum development programme.
