ORDER

As per the Government Orders read as 1st and 2nd paper above, Government have accorded sanction for the 'KSFE-Vidyasree' Micro finance scheme for laptop purchase for students for facilitating online education, limiting the cost of the laptops at an amount of Rs.18,000/-.

2. As per the Government Order read as 3rd paper above, Government approved the empanellment of the 4 OEMs viz. M/s COCONICS, M/s ACER, M/s HP & M/s LENOVO for supply of Laptops against an approved rate for the KSFE-Vidyasree scheme.

3. The price of the laptop models of all OEMs are now vaild upto 31/03/2021.As per the letter read as 4th paper above, the Executive Director, Kudumbashree has requested for extending the price validity of laptops for one more year for the scheme, as the demand was rising up. As per the letter read as 5th paper above, Director, KSITM has conveyed the willingness of the OEMs in extending the price validity of Laptops.

4. Having examined the matter in detail and considering the rise in demand for student laptops, Government are pleased to extend the price validity of Laptops beyond 31/03/2021, till the period as mentioned in the table below, as agreed to by the empanelled OEMs.
