KUDUMBASHREE, State Poverty Eradication Mission is implementing DDUGKY in Kerala. Kudumbashree has also been empanelled by Ministry of Rural Development, Government of India for doing Project Appraisal under DDU-GKY in the Country. Accordingly Kudumbashree have signed MoU with Uttar Pradesh and Rajasthan. Kudumbashree will be signing MoU with states like Nagaland, Maharashtra, Karanataka, etc shortly. Kudumbashree invites applications from the interested Chartered Accountant Firms having valid Registration. Interested Firms having valid Registration may apply to the following address on or before 16th December, 2019:

Kudumbashree will be appraising 300 proposals on an average during November and December, 2019. More proposals will have to be appraised during the course of MoU signing with different states. The Project appraisal of the Proposals shall be carried out on the basis of Notification No. 20/2017 dated 3rd April, 2017. The empanelment will be for one year from the date of MoU.

Conditions (only those agencies who are willing to fulfill these conditions need to apply)

1. Firms should analyze the financial documents submitted by different Agencies during the time of Project Application Submission. A detailed report has to be submitted by Firm within one week from the date of receiving documents. The documents will be send by Kudumbashree through e-mail.

2. Firms should quote the fees for analyzing one Project proposal. L1 will be selected based on the Quote for analyzing one project. The empanelment will be based on the quote per project.
3. The sitting fees for the Chartered Accountant for Pre-Project Approval committee / Project Approval committee meeting will be Rs. 10,000/- (Rupees Ten Thousand only). Expecting 20-30 Pre-PAC/PAC during the period of empanelment.
4. The Chartered Accountants representing the Firms should compulsorily take part in the Pre-PAC/PAC Meetings and the date of PAC will be intimated by Kudumbashree.
5. Pre-Project Approval committee / Project Approval committee may be held within or outside the State. The expenses on travel, boarding and lodgings of those CAs who take part in the PAC and Pre-PAC will be met by Kudumbashree.
