

## **Expression of Interest for Chick supply**

### **Introduction**

Kudumbashree is the state poverty eradication mission of government of Kerala. Kudumbashree Broiler Farmers Producers Company Limited (KBFPCL) is a company formed under Kudumbashree to create availability of quality broiler chicken meat at reasonable price to consumers throughout Kerala under the brand name Kudumbashree Kerala Chicken.

### **Scope of work**

To supply broiler day old chicks to Kerala chicken farms under KBFPCL located in Ernakulam, Thrissur and Kottayam districts based on the demand and purchase order given by the Producer company. Supply and logistics upto the farm should be carried out by the vendor.

### **Eligibility criteria**

The company or agency should have a minimum experience of 3 years in poultry integration.

The applicant must be a profit-making organization for the last 2 years.

### **Chick specifications:**

1. The day of chicks (DOC) should be COBB breed
2. All the chicks should be vaccinated for Marek's disease on "day 0" before delivery
3. Chicks should have homogeneous weight of 40gms with maximum 5% acceptable variation.
4. If the quality of the chicks supplied are not upto the standards, the rate of the chicks should be returned to the company as penalty within 14 days of the supply.

The empaneled agencies has to supply broiler day old chicks (DOC) for the company with the above given specifications.

### **Procedure**

- Interested and eligible firms / agencies should report to the officials / representatives of the company for the selection process at the Kudumbashree District Mission Office, Ernakulam on 25-01-2020 at 11 A.M.
- The companies / firms should possess documentary evidences for meeting the evaluation criteria, qualifying requirements and other conditions
- Documents required are mentioned in annexure A.
- Applications without required documents will be rejected.

### **Selection & Evaluation criteria**

- Based on the documents furnished, the individual agencies will be evaluated by a committee.
- After the evaluation by the committee at the district mission office, Ernakulam, the qualified companies / firms should submit a sealed quote/ bid stating the cost of chick

supply in the format of Venky's COBB 400 Y daily rate  $\pm$  margin including transportation cost. (The cost mentioned in the sealed quote should be the cost per chick above or below the daily chick rate of venky's COBB 400 Y including the suppliers margin / transportation cost).

- Based on the evaluation of the documents furnished by the agencies, the list of qualified agencies will be published before 4PM.
- The sealed quotes furnished by all the qualified agencies will be opened and evaluated by committee at 5 pm in the presence of representatives of all the qualified agencies.
- The lowest quoted agencies will be empaneled temporarily and have to execute an agreement with KBFPCL for the chick and vaccine supply for a period of two months.
- KBFPCL will plan the schedule for the supply of chicks in the three districts and the selected agency will have to supply chicks as per this schedule.
- If the empaneled agency is not supplying chicks after the receipt of work order or if the chicks supplied is of low quality, KBFPCL has the right to black list the company and has the right to issue work order to the remaining qualified agencies or to start with a new chick supply agency.
- The payment for the supplied chicks will be done only after the verification process by the field supervisor incharge regarding the number and quality of the chicks supplied.
- KBFPCL may extend the contract period beyond two months depending upon the requirements of KBFPCL and depending on the performance of the agency.
