Progress of Sanctioned projects in Prime Minister's Awas Yojana [PMAY].

Decision.

The meeting started at 5.30 PM. Chief Secretary chaired the meeting and welcomed all the participants. The Executive Director, Kudumbashree has made a presentation and explained the need for the meeting.

The Ministry of Housing and Urban Development has approved 28976 dwelling units in 90 Urban Local Bodies till date. Construction of 216 dwelling units has been completed. First instalment has been released to 10722 beneficiaries. Building permit has been issued to 12791 beneficiaries.

The Committee reviewed the weekly progress of implementation of projects approved under Pradhan Mantri Awas Yojana [PMAY]. The Committee directed State Level Nodal Agency [SLNA] and Director of Urban Affairs to rigorously monitor the progress of implementation and for necessary intervention to clear the bottle necks.


