

Minutes of the meeting PRM 20 August 2019 – Organization

The review of the organization was taken place in the cabin of Program Officer. DPM and ADMC were present in the meeting from the districts. From the State Mission, Program officer, senior consultant, SAPM and OSS were present. The review meeting started at 11 AM. Major decisions and points discussed are mentioning below.

- The district wise review of the program was done and following discussions were held.
- **Ernakulum District** has pointed out the strategies taken to achieve second position in the inclusion of Elderly NHGs
 - The district had conducted Block level PRMs with the participation of ADMC, DPM, BC and reviewed based on the data of each CDS.
 - BC had involved with the CDS and tried to make each CDS own this program for inclusion.
 - Special Ward-Sabhas were done as part of relationship Kerala.
 - Rangashree street play was done
 - Ernakulum had made an activity calendar for the relationship kerala.
 - In Ernakulum the NHGs prepare food for the pakalveedu.
- **Kozhikode district** had conducted special meeting including Panchayath president, welfare standing committee chairperson at Panchayath level for the inclusion in social NHGs for elderly.
 - As part of Relationship Kerala, vayojana sangamams were done.
 - A video was made in this regard.
 - Giving recognitions to the elders like giving gifts will bring happiness to them.
- Palakkad district has told that, they are mobilizing the PWD, NHG member through the BUDS schools.
- **Program Officer-organization** told the following points in relation with Elderly NHGs
 - State Team will conduct a district level review meeting at kasragode and Malappuram districts soon.
 - Other than above mentioned strategies by the districts, medical camps, bringing to the attention of vilayiruthal samiti, Panchayath samiti and jilla Panchayath will be an advantage for more inclusion.
 - Vayojana Nayam-draft is ready and will send to the district soon. Implementing the “vayojana Nayam “will be the next quarter target of the districts.
 - Special NHG MIS will be done by integrating a module with the state MIS of Kudumbashree.
 - Community counseling for the Elderly NHGs has to be done in the next quarter. The training will be given by KILA to the community counselors.
 - Panchayath projects have to be placed for the elderly NHGs at the time of revision. Minimum 1 lakh project can be ensured from each Panchayath in this regard.
 - For the elderly NHGs who are rejected in getting bank loan, this matter can be notified in SLRC meeting.

- Also when the ENHGs are formed the main purpose of the groups should be health and social factors rather than financial assistance.
- It is important Kudumbashree has to focus on the poorest of poor by the inclusion of the PWDs.
- The ICDS supervisors have the list of PWDs and that list can be used for the inclusion in PWD NHGs.
- DPM has to visit the field along with the BCs then only desired result will come.
- There is no Fund allocation for the special NHGs to start the ME, prathyasha fund can be used in this matter.
- Coastal volunteers review meeting should be called frequently to strengthen the coastal area activities.
- A meeting cum training will be called for the mentors of the prathibha theeram and kayikatheerm, date will be informed soon.
- Debt swapping at coastal area should be done strictly.
- Microcredit plan analysis and activities should be done at coastal areas.
- prathibha theeram and kayikatheeram, livelihood guide is ready and it will be sent to the districts after approval.

Next quarter programs were discussed and detailed presentation of CDS gradation Analysis was done.
