



E – TENDER NOTICE

Competitive E-tenders are invited from reputed, eligible, FSSAI registered qualified firms/manufacturer that has prior experience in working with government organizations for the supply of premix. The tenders are required to be submitted online in a double bid system in the prescribed format.

Required Quantity:

The selected premix manufacturer to supply a maximum of 10000 kg of premix per month, in which the total required quantity of premix is 1,20,000 kg per year. There are 241 nutrimix units under Kudumbashree Mission in Kerala and the premix manufacturer should supply the premix packets of 650gm each to every unit as per their requirement. The vendor has to provide the premix for a period of one-year ie, from February 2022 to February 2023.

Required Composition:

Dosage rate: 0.65% or 650gms/100kg. Each 650gm premix must have the following composition:

It is required that, the packing of premix must be done in 650 gms packets / containers, appropriate for 1 batch of production of fortified Nutrimix.

Quality Control : The successful tenderer should deliver the premix prior to a month before each quarter. A complete certificate of analysis providing necessary details on levels of micronutrients, microbiological and physical purity, colour, odor etc from an external NABL accredited laboratory needs to be shared for each batch of the premix, one week in advance of the initiation of the delivery to the project location to Kudumbashree headquarters and ICDS headquarters of Kerala. Also, delivery of the premix cannot be effective unless the CoA gets approved and a go ahead is given by the Kudumbashree District Mission and ICDS headquarters.

Quality Assurance: The quality of multi-micronutrient premix shall be food grade standard in accordance with the standards as determined in the latest edition of Food Chemicals Codex (FCC) or other internally recognized standards such as US Pharmacopeia (USP) or British Pharmacopeia (BP). These international standards will provide specifications for chemical (including heavy metals and solvent residues), microbiological, physical purity, particle size and potency.

Packaging and Labelling Specifications: The premix shall be packed in hermetically sealed, clean and sound food grade packets / containers in such a way to protect against deterioration, loss in potency or damage due to other factors during its stated shelf life or intended use. The packaging should be adequately and clearly labelled in English and preferably in the regional language. The packaging size as mentioned earlier, must be done in 650gm tetralam bags; the 650 gm bags to be further packed in 5ply corrugated boxes (a maximum of 35packets can be placed per carton), appropriate for 1 batch of production of fortified Amrutham. The delivery schedule is fixed for 4 quarters a year and the successful tenderer should deliver the respective quantity to the 39 collection points across Kerala in these 4 quarters.

The total bid cost includes the costs of the product, packaging, transportation of the product (**inclusive the loading and unloading charges of the product at the specified location**), labour cost etc.

The label specification should broadly carry information such as :

- Intended use (premix for GoK FORTIFICATION PROJECT)
- Caution or warning statements
- Storage protocol & precautions

- Shelf life
- FSSAI license number
- Manufacturing details such as list of ingredients, net weight, date, location, Lot no., Batch no, address of manufacturer, veg logo.

Documents required to be submitted

A copy of the following documents should be enclosed with the tender offer:

- FSSAI Licence
- FSSAI import licence (in case it's imported) and local manufacturing licence of the company
- Copy of PAN No
- Copy of GSTIN No
- Allergen declaration
- Non-GMO certificate/declaration
- Copies of Purchase Order/Agreement/Work Order etc. in support of having the experience in supplying premix to Government organizations.
- List of major clients on letterhead.

Details of Premix Collection Centres

There will be a maximum of 8 collection centres in a district based on the geographical area. Centre wise requirement of premix will be intimated to the company along with the work order. A slight change in collection centres may occur as per the convenience of our women entrepreneurs. The company should deliver the product with utmost care to our collection centres in districts. The details of Collection centres is given as Annexure 1.

General Conditions

1. EMD and Tender form fee should be submitted electronically through NEFT/RTGS/other electronic means by the tenderer to the account details given below. EMD is refundable without interest to unsuccessful parties on finalization of contract.
2. The quoted item must strictly comply with our requirement given in the tender document. Incomplete / conditional offer or tender without EMD will be rejected out rightly.
3. The Management reserves the right to accept/reject any or all bids in part or all without assigning any reason thereof. Any corrigendum/ addendum/ amendment regarding the tender will be published in the official website of Kudumbashree only and all intending tenderers are requested to regularly monitor the same. No separate notifications will be issued for such notices/ amendments/ clarifications etc. in the print media or individually to any bidders.
4. In case, any holiday is declared by the Government on the day of opening, the tenders will be opened online on the next working day at the same time.
5. Bidders are advised to follow the “Instructions for submitting E-Tender” provided in the tender document for online submission of e-tender. By no other means (Fax, email, off-line tender), the bidder is allowed to submit its tender other than through electronic mode in e tender website only. In case the bid submitted through other means shall be rejected.
6. Successful tenderer should deposit Security Deposit of 5% of the total bid price, at the time of executing contract agreement and the deposit will be retained till the expiry of Defect Liability Period.
7. Successful tenderer should enter into a contract (in 200/- stamp paper) with Kudumbashree Mission at his own expense, within 7 days after receipt of work order.
8. The rules under Kerala State Stock Purchase Rules 2013 are applicable to this e tender.
9. The successful tenderer is expected to deliver the first batch of premix by February 2022.
10. If any corrections needed in the tender form, the concerned person should authorize it by putting his signature aside to the corrections he made.
11. All tenderers are requested to submit a sample of premix packet of 650gm to Kudumbashree State Mission on or before December 4,2021 (Kudumbashree State Mission, Trida building, Chalakuzhy Road, Medical College P.O, Trivandrum, 695011)
