

National Urban Livelihood Mission

Minutes of the review meeting of Urban Local Body Secretaries held on 05 August 2017 at Government Guest House Ernakulam

The meeting started by 2.00 pm with Shri. S. Harikishore IAS, Executive Director Kudumbashree in the chair. Director, Urban affairs department Smt. Haritha V Kumar IAS was also present in then meeting. The meeting discussed on the goals and targets to be achieved during the financial year 2017-18 and also reviews the progress in implantation in each ULBs in the state. After the detailed deliberations following decisions were taken.

Decisions taken

Financial Matters

1. The ULBs Payyoli, Pattambi, Parappanangadi, Kunnamkulam that have not submitted the Utilization Certificate of NULM for the financial year 2016-17. These ULBs should submit the UC on or before 19.08.2017, which is the tentative date schedule for next plan review meeting.
2. Chngannur, Alappuzha, Vaikam, North Paravoor, Shornur, Kochi have not transferred the unspent amount of SJSRY to the state mission. These ULBs should transfer the amount to the state mission account within ten days and the will be communicated to the Executive Director, Kudumbashree.

Support for Urban Street Vendors

1. Three ULBs viz; Erattupetta, Wadakkanchery and Mannarkkad have not yet started the nitht survey of street dwellers. In addition Kochi and Thiruvananthapuram have not completed the survey. All these ULBs should complete the survey before 15th August 2017.
2. All the ULBs should constitute the Town Vending Committee at the earliest but not later than 15 September 2017. (list of ULBs not constitutes TVC attached as Annexure 1)
3. The state mission will issues a circular implementation on protection of livelihood and regulation of street vending act 2014 so as to give clarity to the chairman and council members of the ULBs.
4. Data entry and analysis of street vendor survey should be completed not later than 30th August 2017. (list of ULBs attached as annexure 2)

5. ID cards to all identified eligible urban street vendors in the state should be distributed before 30.09.2017.
6. Exertive Director Kudumbashree suggested a list of ULBs that can take up model vendor markets. These ULBs may submit the Vending market development plan and proposals 15.09.2017 so as to complete the implementation during this financial year. (list of ULBs attached as annexure 3)

Shelter for Urban Homeless

1. All ULBs need to consider construction/ refurbishment of shelter homes to accommodate the street dwellers identified through the night survey. ULBs may also consider opening shelter homes by arranging building on rent. NULM can support the ULBs in such cases through providing annual O&M cost permissible under the mission. Proposals of shelter homes from the ULBs desiring to start the shelter should submit the proposal to the State Mission Management Units before 30.08.2017. Varkala, Ponnani, Punalur, Ettumanoor, Perumbavoor, Kochi, Kollam shall submit the DPR.
2. Issue of Technical Sanction for the proposals sanctioned in the 4th SPSC held on 28.03.2017 is still pending in six ULBs. The ULBs viz Kollam, Punaloor, S. Paravoor, Paravoor Kalpetta and Kannur should issue T.S for all approved schemes before 15.09.2017
3. The shelter proposals of Malappuram, Perinthalmanna and Kattappana were not approved in the last State Level Sanctioning Committee. These ULBs should re-submit the DPR before 19.08.2017.
4. Thiruvananthapuram, Kannur, Palkkad, Ottappalam, Kozhikode and Koduvally Urban Local Bodies agreed to submit DPR for construction of shelter homes on or before 15.09.2017. another 4 ULBs can also submit shelter proposal during this financial year. However it should reach the State mission not later than 15.09.2017.

Employment through Skill Training and Placement

1. There are forty ULBs who have not yet enrolled even a single candidate for the Skill Training even though verity of courses in 75 trades is available. All the ULBs should ensure that at least one batch of candidates are enrolled for skill training before 15.09.2017 (list of ULBs attached as annexure 4)
2. All secretaries should take efforts to conduct mobilization camps under ESTP to mobilize candidates and orient them for right trade suitable for their aptitude.

City level Livelihood Centers (CLC).

1. It is observed that there is inordinate delay from ULBs in making the sanctioned CLCs functional. Hence, ULBs viz Kollam, Kalpetta, Kattappana, Thrikkakkara, Thrissur and Palakkad should take immediate steps to make CLCs functional before 30.09.2017.
2. District Mission Coordinators of Kudumbashree should organize a meeting of municipal chairmen of their concerned district in connection with making CLC functional in all ULBs. Date of such district meeting may be confirmed after state Plan Review Meeting (PRM) of Kudumbashree scheduled for 18 & 19th August 2017.

Revolving Fund

1. All ULBs should submit proposal for claiming Revolving Funds to NHGs as well as to ADS before 30.09.2017

Self Employment Programme (SEP).

1. There are instances of not releasing any amount of interest subsidy to CDS from ULBs. These ULBs should release the same before 30.08.2017.
